CalWORKs Program Guide Letter No. 220

Subject **CalWORKs COST OF LIVING ADJUSTMENT (COLA) INCREASE TO THE MINIMUM BASIC STANDARD OF ADEQUATE CARE (MBSAC) AND INCOME IN-KIND (IIK) LEVELS**

Effective Date: July 1, 2010

Reference All County Letter (ACL) No. 10-34

Purpose The purpose of this letter is to inform staff of the Cost of Living Adjustment (COLA).

Background CalWORKs MAP, MBSAC and Income In-Kind levels are adjusted annually to reflect any increases or decreases in the cost of living.

This year the adjustments include:

- **1.57 percent** increase to the Minimum Basic Standard of Adequate Care (MBSAC) and Income In-Kind levels.
 - COLA increase **suspension** to the Maximum Aid Payment (MAP) levels.

Retroactive
Eligibility for
Denied
Applications

The new MBSAC levels are to be used in determining applicant financial eligibility for those families that apply for CalWORKs on or after July 1, 2010.

Human Services Specialists (HSS) are instructed to review only previously denied applications which were denied solely for failing the applicant financial eligibility income test for July 2010 due to the higher MBSAC level (please refer to Attachment 1).

HSSs shall make any necessary retroactive and all prospective changes effective as soon as administratively possible to implement the increase in the MBSAC levels and retroactively approve those applications, if appropriate.

**Income In-
Kind (IIK)
Levels**

HSSs shall review the list of continuing cases, (please refer to Attachment 2), with IIK and update the values manually as appropriate:

- If the IIK amount on the case needs to reflect the new value, staff must run EDBC and authorize to update with the new IIK value.
- If the IIK amount does not need to be updated (client receives lower IIK value), staff need take no action.

The actions to increase the IIK value must be completed before Notice of Action (NOA) deadline in August 2010 for the budget month of September 2010 and ongoing.

Per Quarterly Reporting (QR) regulations, increased IIK levels are considered county-initiated. They may occur at any time during the Payment Quarter in which the change occurred.

Note: The increase in IIK levels will be effective for new applicants July 1, 2010.

MAP COLA
Suspension

The California Department of Social Services (CDSS) has announced that, beginning in the **2010-11 fiscal year**, no adjustment to the MAP levels shall be made unless otherwise specified by statute.

RCA and TCVAP Impact	These instructions for the MBSAC and Income In-Kind changes also apply to Refugee Cash Assistance (RCA) and Trafficking and Crime Victims Assistance Program (TCVAP) applicants and recipients.

Food Stamp Program Impact	Recipients receiving both Food Stamps and CalWORKs, RCA, or TCVAP will likely result in an increase in their food stamp allotment amounts due to the decrease in their cash grant.
